



## WINE & DINE – ON US GIVEAWAY OFFICIAL RULES

### NO PURCHASE NECESSARY TO ENTER OR WIN

#### ELIGIBILITY:

You may enter this sweepstakes beginning Saturday, September 14, 2019 through Sunday, February 2, 2020. Must be 21 years or older to enter. Credit union membership not required. Employees and volunteers of Tendto Credit Union and their immediate family members (spouse, parents, children, siblings and their spouses or individuals living in the same household) are not eligible to participate in the sweepstakes.

#### HOW TO ENTER:

You may enter the sweepstakes in one of two ways: (1) Complete the online entry form at [tendtocu.com/Wine-on-the-Lake](http://tendtocu.com/Wine-on-the-Lake) or (2) by legibly hand printing on a 3" x 5" card the words: "2020 Wine and Dine – On Us" along with your name, email address, street address and telephone number and mailing the entry to Tendto Credit Union, 1129 State St., Erie, PA 16501. Only one entry per person is permitted. If multiple entries are received, only the first entry received will be entered into the sweepstakes.

#### PRIZE:

One (1) winner will be selected and will receive the "Wine and Dine – On Us" package valued at \$400. Prize includes two (2) VIP Wine on the Lake tickets, dinner and an overnight stay at a bayfront hotel on Saturday, February 22, 2020. Only entries received within the above specified time frame will be eligible for the prize drawing. No alternative prize or other substitution is permitted, except by the Credit Union in the event of prize unavailability. All federal, state and local taxes are the sole responsibility of the winner.

#### SELECTION OF WINNER:

Winner, as specified above, will be determined by random drawing from all eligible participants on or around February 3, 2020. All decisions are final and binding. Odds of winning will be determined by the number of participants. Winner will be notified on or around February 3, 2020. Winner will have three (3) days from notification to claim the prize. If the winner does not claim the prize during the specified time period, a new winner will be drawn from all eligible participants.
